2. The availability and confirmation of seat at the time of travel should be confirmed before submitting the quotation.
3. The Travel agents are requested to quote the rates as per the sectors given as above and will be selected for the most direct and economical route.
4. The travel agent shall quote in full economy class fare tickets (include refreshment & meals) and are requested not to quote for the budget airlines.
5. Will not accept unconditional quotation like an increase of airfares and changing of airlines at the time of travel after the issue of air ticket(s).
6. In case the lowest bidder withdraws his/her bid after award of air ticketing, then the second lowest bidder shall be asked to purchase and issue ticket(s) and the difference amount shall be borne by the lowest bidder.
7. Should able to provide credit facilities for a period of 30 days from the date of issue of tickets/receipts of invoices whichever is later.
8. The quotation should be submitted along with a security deposit of **Nu. 10,000/- (Ten thousand)** in the form of demand draft in favour of Director, Royal Institute of Management, Simtokha.
